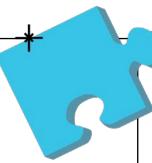


Parameters Ordinance GO Bonds

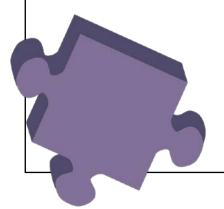
- Sets the maximum amount of bonds
 - \$13,200,000 for Prop. D
 - \$17,100,000 possible refunding
- True interest cost will not exceed
 - 4.5% for Prop. D bonds
 - 3.65% for refunding bonds
- Refunding must produce a net PV savings of at least 5.50%
- Final maturity shall not exceed February 15, 2044.
- Delegates authority to City Manager or Asst. City Manager, CFO for closing of sale.



Proposed Debt Issue FY24 General Obligation Bonds

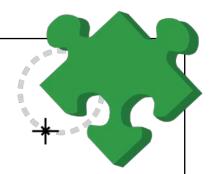

***Projected assumptions

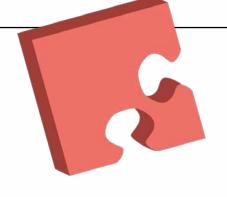
Series 2014 Certificates \$16,990,000

Net Present Value of Savings 5.50%



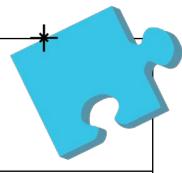


Parameters Ordinance CO Bonds

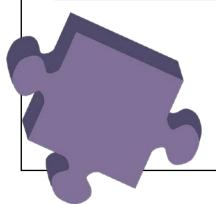
- Sets the maximum amount of bonds
 - \$43,300,000
- True interest cost will not exceed
 - 4.5%
- Final maturity shall not exceed February 15, 2044.
- Delegates authority to City Manager or Asst. City Manager, CFO for closing of sale.



Proposed Debt Issue FY24 Certificates of Obligation - Governmental Projects

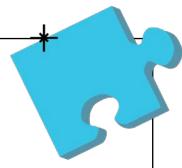

City-Wide Fiber	\$1,100,000	Fiber Optic Infrastructure and Extension for Signals
Existing Facility Upgrades/New Facility Projects	\$12,500,000	Design Public Works Operations Center Implementation of Facilities Master Plan approved in FY23 Budget Facilities Maintenance Revolver (e.g. HVAC replacements, Fire Station Doors)
Streets/Sidewalks/Paths	\$5,500,000	Streets Revolver and Sidewalks near schools, A&M, Wellborn, etc.
Parks & Recreational Facilities	\$7,700,000	Ballfield development and equipment replacement at Bee Creek, Brothers, Central, Southern Oaks, Merry Oaks, University Park etc.

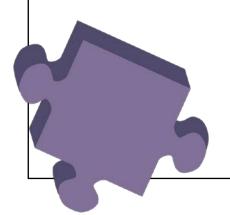




Proposed Debt Issue FY24 Certificates of Obligation - Utilities

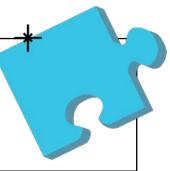
